OTHER BUSINESS

Janet Anderson noted that coming changes to the Sunshine Act may require that the boards return to in person meetings; the state oversight division is looking into how to move forward. Any changes are expected to affect the September meetings. It was noted that there is merit in both virtual and in person meetings, but safety must be considered and as such virtual should always be an option for participation. The solicitor noted that the emergency declaration did allow for virtual meetings in some instances, but now that it has been repealed there is confusion on who is required to meet in person at all. The CLEOs suggested meeting virtual then consider meeting again in person, pending further guidance from the state. The solicitor noted that he would also try to get clarification.
