

## **NWPA WDB POLICY - 210**

Rev. Level: C

# **Youth Incentive Policy**

The Workforce Innovation and Opportunity Act (WIOA) allows funding for eligible youth to be used as incentives to recognize achievement in identified workforce development programs. The NWPA Job Connect Board has developed this policy to ensure that appropriate and necessary incentives to encourage eligible youth participants in the local workforce development area (LWDA) to achieve specific goals tied to training activities and work experiences. This policy is intended to ensure compliance with all federal and state regulations by providing guidance to NWPA Job Connect Board, NWPA Job Connect Board staff, fiscal agent staff, program services contractor staff in the local PA CareerLink® system on the use of youth incentives in the LWDA. This policy applies to all NWPA Job Connect Board funded in-school youth (ISY) and out-of-school youth (OSY) participants. Youth program services staff are responsible for implementing this policy.

It is important to note that incentives are not an entitlement. All incentive awards will be subject to availability and budgeting of WIOA Youth Program funds and applied at the discretion of the NWPA Job Connect Board Incentives shall not be issued as actual direct cash payments to youth participants.

### **DEFINITIONS**

<u>INCENTIVE</u>: An incentive is a payment to an enrolled youth participant for successful participation and achievement of expected outcomes as identified in the participant's Individual Service Strategy (ISS). The incentive must be linked to an achievement and must be related to a training and/or education activity that specifically addresses at least one of the fourteen (14) required Youth Program elements. Such achievements must be documented in the participant's Individual Service Strategy (ISS) as the basis for an incentive payment.

Incentives are considered awards to youth participants for their achievement and successful participation in workforce development activities. The following is a list of incentives that may be awarded at the discretion of NWPA Job Connect Board to youth participants based on funding availability:

1) Basic Skills Improvement Incentive: Up to \$50.00

<u>Documentation Required</u>: Participants identified as basic skills deficient in either reading and/or math must be post-tested at least once by the end of the first year after enrollment. Participants who successfully complete all CASAS re-testing requirements within 12 months from the date of the first youth service and who increase his/her CASAS score in math and/or reading by two (2) Grade Level Equivalencies or one (1) Education Functioning Level (EFL) can receive, while actively participating and enrolled in the Youth Program, an incentive not to exceed a total of \$50.00 (reading \$25.00 and/or math

\$25.00). A copy of the CASAS level increase must be included in the participant's file and documented in CWDS.

2) Attainment of High School Diploma/GED/High School Equivalency or Industry Recognized Credential or Successful Completion of Work Experience and/or On-the-Job Training: \$50.00

<u>Documentation Required</u>: Youth participants are eligible for this one-time incentive following the submission of the appropriate respective certificate and/or official document from the test site verifying the participant successfully passed the testing requirements or successful completion of work experience.

3) Post-Secondary School Incentive: \$50.00

<u>Documentation Required</u>: Youth participants are eligible for this one-time incentive following the successful completion of their post-secondary education training. Documentation showing successful completion must be received and uploaded into CWDS prior to incentive award.

4) Employment 2<sup>nd</sup> quarter post-exit: \$50.00

Documentation required: Youth participants who have retained employment for two quarters post exit must provide pay stubs or a letter from their employer showing they are employed.

### **ELIGIBILITY**

Participants must meet eligibility requirements for a program before receiving gift card incentive payments purchased with the respective program funds. The following are the eligibility requirements for youth incentives:

- Participants must be a WIOA or TANF eligible youth participant
- Participants must be active and in good standing with a program, including regular contact with youth program staff
- Participants must have achieved an outcome listed as a goal within their Individual Service Strategy (ISS)

Each NWPA Job Connect Board funded in-school youth (ISY) and out-of-school youth (OSY) program services contractor that utilizes incentives must maintain a clear and concise written incentive policy that outlines a uniform and consistent strategy for awarding incentives with NWPA WDB funds.

At a minimum, the program service provider's incentive policy must include:

- The method and justification for the issuance of incentives
- The method by which gift cards for incentives are purchased
- The method by which gift cards for incentives are stored
- The internal controls for incentive awards (e.g. number of signatures required)
- Compliance and alignment with WDB Incentive Policy #209

 Compliance and alignment with Uniform Guidance at 2 CFR Part 200 and 20 CFR §681.640.

Programs may not award direct cash payments to youth participants as part of an incentive strategy. A cap of \$100 in value per instance (e.g., obtainment of a GED, post-secondary education completion, sustained employment for two quarters)) is required. Participants cannot receive multiple incentives for the same activity. A participant could receive up to a maximum of \$200 upon successful completion of benchmarks and documentation in the participant file.

- Incentives may not include entertainment costs, such as movie or event tickets or gift cards to movie theaters
- Incentive payments may only be awarded in recognition of an achievement directly tied to training and work experience and must be tied to the goals of the program
- Incentives must be administered in a manner that ensures all participants receive equal awards for equal achievements
- At least three (3) individuals must sign off to indicate that an incentive has been awarded: a program services supervisor, a program services staff member, and the participant receiving the incentive
- The program service contractor's written incentive policy must clearly describe this process

Reports to the fiscal agent must be provided on the status of issuing incentives at least monthly.
