# **DISCUSSION: PROCESS TO UPDATE THE PFP HANDBOOK**

The consensus of the group was for board staff to propose any PFP bylaws changes and then provide those changes to Attorney Chris Gabriel's office for review and recommendation to the CLEOs.

# **COMPANION LIFE SHORT TERM DISABILITY RENEWAL**
