## WELCOME/ROLL CALL/VISITOR RECOGNITION/PUBLIC COMMENT

Commissioner Abramovic called the meeting to order at 4:11 PM. Roll call was taken. It was noted that there was a quorum. No public comment was received. The meeting was recorded and the agenda was posted in the chat.

## APPROVAL OF MEETING MINUTES

The minutes for the September 20, 2024 Partners for Performance board meeting were presented for approval.

### **MOTION**

It was <u>moved</u> by Commissioner Snyder and <u>seconded</u> by Commissioner Durbin to approve the minutes for the September 20, 2024 meeting as presented. All were in favor. There were no abstentions. <u>Motion passed and carried</u>.

### **REVIEW OF PREVIOUS ACTION ITEMS**

Attorney Stephanie Fera stated that there is a new requirement that the federal government put out for small businesses that people with financial interest in the business have to file a report listing certain personal information (Beneficial Ownership Information Reporting). Because Partners for Performance is a nonprofit organization, we do not have to submit this report.

### PFP FISCAL REPORT

Given the discussion at the previous meeting, there was no additional discussion needed on the fiscal report.

All were in favor. There were no abstentions. <u>Motion passed and carried</u>.

Lisa Miller stated that a draft of the job description was presented at the last meeting. This is the final version. Commissioner Abramovic stated that since Attorney Fera has not had a chance to review this, the item should be tabled for the next meeting.

### **MOTION**

It was <u>moved</u> by Commissioner Snyder and <u>seconded</u> by Commissioner Durbin to table the approval of the Executive Director job description to the next meeting. All were in favor. There were no abstentions. <u>Motion passed and carried</u>.

Lisa Miller stated that we are researching the purchase of a laptop and several microphones to facilitate future in-person board meetings.
